Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.





Professional handlers or agents are only permitted to exhibit in FSS Open Shows if they are listed as an owner of record of the dog being exhibited. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.*

Dogs should be physically sound. No dog shall be judged if it is taped, bandaged, glued or has stitches anywhere including ears or tail in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the event grounds.

That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration.
